

As a voluntary participant (“Participant”) in either the FIAT Hotel Auto Livery Service Program or the Hotel Guest Vehicle Loaner Program (collectively, the “Program”), I understand and agree to the following Terms and Conditions:

The FIAT Hotel Auto Livery Service Program is available at the following Loews Hotels: Loews Santa Monica Beach Hotel, Loews Hollywood Hotel, Loews Madison Hotel, Loews Regency Hotel, and Loews Miami Beach Hotel (each hotel, a “Participating Hotel”).

The Hotel Guest Vehicle Loaner Program is only available at the following Loews Hotels: Loews Santa Monica Beach Hotel, Loews Hollywood Hotel, and Loews Miami Beach Hotel and only available to drivers who are at least 18 years of age with a current, unrestricted driver’s license.

A Participant in the Hotel Guest Vehicle Loaner Program shall read and agree to the terms and conditions of the Hotel Guest Vehicle Loan Service, Declaration of Eligibility, Indemnification and Release.

Making a reservation does not guarantee a reservation for the Program. Participant will receive confirmation of his/her reservation via a phone call or email from a FIAT Ambassador. Service is subject to availability. Service is available only during published service hours and market-specific driving radius at the Participating Hotels.

Participants under the age of 18 must be accompanied by an adult during a chauffeured ride.

Alcohol and glass containers are not permitted in any vehicle. Smoking is not permitted in any vehicle.

All occupants of the vehicle will properly utilize all vehicle/occupant restraint systems, including use of child protective restraints/seats. Participants are responsible for supplying child protective restraints/seats.

PARTIPANT AGREES TO ENSURE THAT ALL OCCUPANTS OF THE VEHICLE USE SEAT BELTS AND CHILD RESTRAINTS PROPERLY AT ALL TIMES, REGARDLESS OF WHETHER REQUIRED BY LAW.

Pets are permitted in the vehicle if contained in a secure carrier or properly secured using a safety restraint harness or seat belt.

Participant agrees to defend, indemnify and hold Loews Hotels, Inc., Ansira Partners, Inc., Chrysler Group LLC, each Participating Hotel, its owner and operator, and their parents, subsidiaries, agents and their respective directors, officers, shareholders, agents and/or employees (“Releasees”) harmless from and against all liabilities, obligations, losses, damages, penalties, claims, actions, suits, costs, charges and expenses, including without limitation, fees and expenses of legal counsel and expert witnesses, which may be imposed on or incurred by or asserted against directly or indirectly the Releasees, or any of them, by reason or actual or alleged personal injuries, property damage, wrongful death or any other damages arising directly or indirectly out of my participation in the Program, whether caused by my negligence or the concurrent negligence of another party. I assume full responsibility for and risk of bodily injury, death or property damage related to my participation in the Program, including that resulting from the negligence of Releasees.

The Releasees shall not be liable for circumstances beyond their control, including but not limited to, weather, road conditions, and breakdowns.

The Releasees assume no responsibility for lost or damaged baggage, personal belongings or any items left in the vehicle.
